Ms Lynette Faye Johnson (Faye)

Dear Faye,

I make it clear to you that everything that both Harry and I owned is now mine. Harry's will left everything to me. Harry did not leave anything to you at all. I say it again – Harry's will leaves nothing to you and you are not an executor of his will therefore you are not entitled to take anything of Harry's or mine. All our assets (Harry and Lynette's) were owned jointly with the exception of the motor vehicles. This means that these assets automatically belong to Lynette Croll. This means there is little need for probate and distribution of assets. Probate is only required for that small number of assets that were registered in Harry's name only.

I personally am in fear of you and demand that all further correspondence is by mail only. If you again come here and distress me I will seek the protection of the courts.

The following is a list of items that you have taken from me. It is by no means exhaustive and as time goes by and I think of more, I will be adding to this list. I am demanding that you return these items forthwith. I give you 28 days in which to return these items and / or make restitution, If you have not done so within this time this matter will go to court.

## Summary of events:

Henry Theodore Croll (Harry) died on the 15th June 2003.

On the 19th June 2003 Faye, I verily believe, tried to sell the Edgar Road Longwary farm to Gerlach. I know this because Amber Johnston told me that John Gerlach had told people in the Longwary pub that the Longwary farm was for sale and that Faye had called him trying to sell it to him. Bill Moore, the farm tenant, told me that John Gerlach had visited him and told him he will have to get a new place to live because the Longwary farm was for sale. Faye had called him to sell the farm to him.

On the 20th June Faye came home here very distressed, she said words like "What am I, the dumb daughter - John Kyne (Lynette Croll's solicitor) had told her that Harry had

made a new will and removed her as executor to his will. If Faye was an Executor I verily believe she would have thought she had the power to sell up all of the properties owned by Harry and Lynette. John Kyne has told Harry that he was interested in buying his longwarry farm - I guess Faye rang him, among others, trying to find interest in purchasing the farm.

Faye found out she was not executor of Harry's will, and so could not sell the farms and take the moneys.

Thus began a string of harassments.

Faye called Yoka and told her to get Trevor back to Brisbane, "Trevor was in the way and not pulling his weight. He was sleeping in and causing lots of problems"

Faye told Glenn Johnston, Leonie Tribuzi, Cheryl Prater, Laney Stevens, that Trevor had taken heaps of cash, had taken bottles of coins and had taken money from bank accounts. George Tribuzi called Trevor a crook. This no doubt is because of what Faye has been saying.

Faye also made claims to Trevor Croll, Glenn Johnston, Leonie Tribuzi, Cheryl Prater, Laney Stevens, Bruce James that Lynette Croll was incapacitated and needed care, she would be better off in a retirement home and that she (Faye) should be the legal guardian and could look after the properties and assets for her. I verily believe Faye was intending to become Lynette Croll's legal guardian so she could take everything.

Leonie Tribuzi and Laney Stevens tells Lynette Croll, Faye has been getting legal advice on how to contest Harry's will and how Faye could become Lynette's legal guardian. Laney also tells how Faye tells her that Lynette Croll is in a bad way physically – she is very ill has had several strokes since Harry's death. Laney also says how Faye tells that Trevor Croll is manipulating Lynette Croll and brainwashing her and taking all her money.

Faye Johnston set out to cause Lynette Croll maximum distress and harm after the death of her husband Harry Croll. She did this by:

- Faye rearranged the furniture in a manner that would distress Lynette,
- Faye threw out Lynette's medications
- Faye stole Harry's best clothes.
- She removed significant evidence Harry has even existed.
- Faye stole very special and personal German letters from Harry's father.
- Faye stole family photos that belonged to Lynette Croll.
- Faye was abusive, short and difficult and caused Lynette stress.
- Faye stole cutlery,
- Faye stole Lynette's best linen and bed spreads.
- Lynette's keepsakes and many personal items,
- Faye stole 5 bags of special money and coins many being the round silver 50cent coins that Lynette had collected in the fifteen years she was running the Nar Nar Goon Hotel with Harry.

- Faye stole some of Lynette's jewelry with significant emotional attachment.
- Faye stole \$50,000 plus in Commonwealth of Australia bank notes that Lynette had collected while running the above mentioned Hotel.
- Faye stole most of Harry's best clothes
- Faye stole some of Lynette's most favorite keepsake dresses.

Lynette had a medical trauma which was diagnosed by the doctor as a stroke, but one made up of lots of little blood clots. Lynette 's right leg became numb and she lost her balance. We went looking for her a blood thinning tablets and they were missing. I called Faye and Faye lied that a blood thinning tablet threw them out. I told her I did not believe her, she said are you calling me a liar, I said yes. I asked her about Harry's clothes that had been stolen - she said she knew nothing, I again called her a liar.

A male person called Trevor told him that Faye had organized for a hit man to kill me. He warned Trevor to be very careful. Trevor has taken security steps and has purchased and installed a video camera and sensor lights around the house. He has also told the local Police what he was told. They gave him a special number to call if anything strange happens around the house. Faye and Alan have been videoed being in the house at 2 Flett Street when both Trevor and Lynette were not home.
