Subsequent to Australia Post's 2 May 2006 subpoena response (copies enclosed) Mr Croll requested that further enquires be instigated at the Warragul Delivery Centre, and Australia Post's AddressPost Unit in relation to mail redirections issued in 2002 to 2003, regarding the address 2 Flett St Bunyip Victoria 3815. Mr Croll also requested that a further search be conducted at Australia Post's Corporate Board & Shareholder Liaison Unit for any letters from politicians to Australia Post and Australia Post's replies.

I seek the Court's indulgence and wish to express my sincere apologies on behalf of Australia Post to the Court and to Mr Croll for the delay in providing all the documents sought in the Subpoenas.
